### 1. **APOLOGIES**

# 4. SEAFRONT AND DOWNS STABILISATION SCHEMES

Further to Minute 6 of the Special Meeting held to discuss Policy and Planning matters on Monday 17<sup>th</sup> March 2014, the Town Clerk again updated those present on the progress of the Seafront and Downs Stabilisation Schemes. Detailed consideration was given to the proposals put forward by the contractors to stabilise the central section of the Recreation Ground, below the war memorial. It was acknowledged that if this was to be undertaken the memorial itself would have to be dismantled and relocated. It was explained that this work had become necessary due to the unprecedented wet weather and geological anomalies identified during the excavations.

Advice received from Purbeck District Council's Planning Department was noted. Reference was also made to the Interim Costs Report provided by the Council's Quantity Surveyor and Council officers explained the availability of funds to undertake

this additional work. It was noted that the Council's Treasury Management Strategy and Capital Programme would need to be reviewed in light of this additional expenditure.

It was proposed by the Town Mayor, seconded by Councillor Poultney, and RESOLVED UNANIMOUSLY:-

To approve the proposal to reduce the levels to the central section of the Recreation Ground in order to re-profile the slope, and to authorise the dismantling and re-location of the war memorial, at an estimated cost of £137,000.

During the discussion it was noted that a further decision would be required in coming weeks regarding the requirement to soil nail the land in question.
