1. **APOLOGIES**

2. **DECLARATIONS OF INTEREST**

3. TREASURY MANAGEMENT STRATEGY STATEMENT AND INVESTMENT STRATEGY 2013/14 to 2015/16

Copies of the draft Treasury Management Strategy Statement and Investment Strategy 2013/14 to 2015/16 had been circulated to all Members prior to the Meeting.

The document detailed the Council's projected investment/borrowing strategy over the next 3 years, and outlined the parameters within which the Council's officers could operate with regards to the annual investment strategy over the next financial year.

Following a brief discussion, it was RESOLVED:-

To approve the draft Treasury Management Strategy Statement and Investment Strategy for submission to the Estimates meeting on 21st January 2013.

4. PARISH PRECEPTS 2013/14 - CHANGES TO COUNCIL TAX BASE

Further to Minute No. 120 (b) of the Council meeting held on 7th January 2013, detailed consideration was given to the proposed changes to local government finance which would reflect in the Council Tax base, and the impact that these changes may have on Parish Precepts in 2013/14 and future years.

In light of the uncertainty surrounding the impact of government legislation and the effect this may have on future funding from the District Council, and the possibility of 'capping' of town and parish councils in future years, additional information had been prepared for consideration by the Town Council when setting its Council Tax precept for 2013/14.

Following a lengthy discussion, it was proposed by the Town Mayor, seconded by Councillor Pratt, and RESOLVED UNANIMOUSLY:-

To adhere to the decision of the Finance and Performance Management Committee held on 12th December 2012 (Minute No. 4) that the draft Estimates 2013/14 incorporating a proposed increase in Council Tax precept of 2.5% be approved for final consideration by the full Council on 21st January 2013.

In accepting the Report, Members re-affirmed the Council's main priority as progressing the seafront and Downs stabilisation schemes, and were also pleased to note the satisfactory conclusion of several legal matters.
