4) Tree Preservation Order – relating to a tree on land at 30 Rabling Road, Swanage

A certified copy of a Tree Preservation Order relating to a sweet chestnut tree on land at 30 Rabling Road, Swanage, together with a copy of the formal notice of the making of the Order, had been received from Purbeck District Council (PDC). The Order had been made as it was felt that the amenity value of the area was greatly enhanced by the tree which was of importance to the local environment. The Order came into force on a provisional basis on 3rd November 2015 and would remain in force for six months, during which time PDC would consider any objections or comments received and decide whether the Order should be given permanent status. A brief discussion ensued, and it was AGREED:

That no objection be raised to the Tree
Preservation Order being made at
30 Rabling Road, Swanage.

5) Applications for tree works - opportunity to raise any matters of concern

There were no matters raised on this occasion. However, it was reported that, in view of recent queries raised by Town and Parish Councils regarding Tree Wardens, PDC would be providing guidance notes to local councils in due course.

Consultation

6) To note receipt of the following consultation documents and to determine the Council's preferred method of response:

a) South Western Rail Franchise – Stakeholder Consultation

The Department for Transport was seeking feedback and input on priorities for the next South Western Rail Franchise. A brief discussion was held, and comments were made about the fact that the document was so extensive and comprehensive. Members felt that more time was required to assess the information, and list of consultation questions contained therein, before submitting the Town Council's consultation response form. As the consultation did not close until 9th February 2016, it was therefore proposed by Councillor Poultney, seconded by Councillor Bonfield and RESOLVED UNANIMOUSLY:

That this item be deferred for further
consideration at the next Committee
Meeting being held on 4th January 2016,
to allow Councillors more time to review
the consultation document in greater detail.

b) Youth Services Consultation online survey, and proposed changes to youth services in Swanage

Further to Minute No. 6 a) of the Planning and Consultation Committee Meeting held on 5th October 2015, a briefing note had been received from Dorset County Council (DCC) on their proposed changes to youth services. DCC had reviewed the services provided by the County Council in order to make significant savings of £1m from a current £2.2m budget, and after six weeks of engagement had now produced a single proposal which was to withdraw from the 22 youth clubs they operated in the County and focus limited resources on targeted youth work. This would mean that Swanage Youth Centre would close. However, DCC would be prepared to talk to other organisations/anyone who would be interested in operating these premises. The consultation documents were available on the Dorsetforyou.com website, along with a further online survey inviting comments on the proposals which would only be open until 16th December 2015.

A discussion ensued and it was reported that the Swanage Youth Club Advisory Group had held an open meeting on 27th November 2015 to discuss these proposals, and had invited anyone who had an interest in youth work in Swanage. A second meeting had been arranged for 14th December 2015 to discuss the development of a possible joint strategy to put forward alternative proposals to DCC. Concerns were again raised about the possible effects that the proposed budget cuts may have in the town, including the longer term consequences, e.g. social care, young people on the streets and the possible increased police/court service costs.

It was noted that the DCC Cabinet would be making a decision on the proposals on 13th January 2016, and this would be followed by a Formal Staff Consultation from 18th January to 3rd March 2016. If the proposals were approved, DCC would start implementing changes from June 2016. A further discussion was held regarding the consultation timeline, and it was felt by all Members that this was wholly unacceptable and did not give adequate time for interested parties to discuss/develop alternative proposals. It was therefore AGREED:

That a strongly worded letter should be sent to Dorset County Council objecting to the proposed closure of Swanage Youth Centre and requesting an extension to the consultation period to enable alternative options to be developed.

It was further agreed that this matter should be included on a future Monthly Council Meeting agenda.

7) Items of Information and Matters for Forthcoming Agendas

There were no matters to report.

8) Date of next Meeting
